**Sub: Grant of First Time Affiliation to the B.C.A. - I Course (English Medium)  
for the academic year 2010-11.**

Sir/Madam,

This is to inform you that, the Vice-Chancellor vide her order No. Affi.Gen.1/ V.C. Order /2010-11/1914 dated November 30, 2010 and as per the recommendations of the Local Inquiry Committee, the First Time Affiliation has been granted to the B.C.A. - I Course (English Medium), with intake capacity of 60 students, conducted by the Dnyankunj Shikshan Sevabhavi Sanstha's Dnyankunj College of Information Technology & Management, At. Oras, Sindhudurg Nagari, Tal. Kudal, Dist. Sindhudurg, for the academic year 2010-11, in accordance with the provisions of Section 81, 82 and 83 of the *Maharashtra Universities Act, 1994*, subject to submission of a written undertaking by the Trust thereby agreeing to fulfill all the conditions of affiliation as stipulated under Section 81 of the Maharashtra Universities Act 1994, and as stipulated by the Local Inquiry Committee, within the prescribed time limit, and, that in default, the First Time Affiliation so granted shall be withdrawn/terminated, as per the procedure laid down for the purpose.

It may be noted that, the First Time Affiliation has been granted for one academic year (i.e. June, 2010 - May, 2011) to teach the subjects/methods as per University syllabus for the B.C.A. Course, as recommended by the Local Inquiry Committee:

The First Time Affiliation to the B.C.A. - I course for the academic year 2010-11, is granted on the following terms and conditions:

1. The joining report of the above faculty, needs to be submitted to the University within one month from the receipt of this letter.

2. That the Trust / Samstha / Mandal / Society shall appoint the following staff, as per the qualifications and **procedures\*** prescribed by the University Grants Commission/University:
  - i. Teaching staff including Principal
  - ii. Librarian
  - iii. Non Teaching staff
  - iv. Technical/Laboratory Staff, wherever applicable
3. That the Trust/Samstha/Mandal/Society shall meet the financial deficits, if any, by making an outright grant to the College from its own funds.
4. That the Trust shall maintain the rosters for reservation of posts of teaching and non-teaching staff, as per the reservation policy of the State Government and maintain service books and the provident fund registers of all employees.
5. That the Trust shall provide facilities for library, books and journals, furniture, fixtures and fittings for class room, office, laboratories, library, and staff room.
6. That the Trust shall constitute the Local Managing Committee, as prescribed under Section 85 of the *Maharashtra Universities Act, 1994* (copy enclosed).
7. That the Trust shall comply with the conditions laid down by the concerned State Government with regard to admission of students belonging to SC/ST/DT/NT/OBC categories.
8. That the Trust shall comply with the Orders/directives issued by the Chancellor, the Vice Chancellor and other officers of the University in exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances, Rules and Regulations
9. That the Trust shall send to the University, the progress reports of the compliance of the above conditions from time to time.
10. That the College/Trust shall keep the Fixed Deposit of Rs.6 Lacs in any Nationalised Bank in an account in the joint name of the Registrar, SNT Women's University and the Chairman/President of the said Trust for a period of 6 years. This deposit will have to be renewed with the accrued interest for further 6 years at the end of maturity date i.e. after 6 years and the copy of the receipt of the fixed deposit be produced to this University.

**\*Procedure:** The trust is to prepare draft advertisement for the post of teaching staff and get it approved by the Director, B.C.U.D. through Deputy Registrar, Special Cell of the University.

11. That the Trust/Samstha/Mandal/Society shall give an undertaking on stamp paper worth Rs. 100/- wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994 and also agree to abide by the rules and regulations as may be framed by the University from time to time.
12. The conditions of First Time Affiliation and the observations stipulated by the Local Inquiry Committee, shall also be complied with by the Trust/Sanstha/Mandal/Society within the given time limit:
13. You are also required to submit an undertaking to the undersigned on Rs.100/- non-judicial stamp paper, stating that your Trust knows that the First Time Affiliation has been granted to you for the academic year 2010-11 on "self finance basis" and in future your Trust shall not ask for any financial assistance either from the Government or from the University.

You are requested to note the same and do the needful and send a copy of the undertaking on the stamp paper of Rs.100/- about the conditions mentioned under Sr. No.11, 12 & 13.
